<u>BACKGROUND IN BRIEF</u>: The Cantonment Board, Roorkee invites bids in prescribed E-Tender form through portal at <a href="https://defproc.gov.in/">https://defproc.gov.in/</a> under TWO BID SYSTEM from experienced and reputed organizations registered with Animal Welfare Board of India for carrying out the sterilization operation of wandering stray dogs to stop their birth and control the dog population and also to give them anti rabies vaccine.

- 2. <u>Manner of Depositing the Bids</u>. The bids will be submitted in the following manner:- The actions will be in physical and online form as described below:
  - (a) Documents Required in Physical Form The original of following tender supporting documents shall be submitted physically by hand under the covering letter addressed to the Chief Executive Officer, Cantonment Board Roorkee or by post / courier in the envelop and write the name of the contract (STERILIZATION AND VACCINATION OF STRAY DOGS 2024-25) in capital letter on envelop and seal the envelop and same should reach this office on or before bid submission end date and time. The Cantonment Board Roorkee will not be responsible for any postal/courier delay, and if the documents are not submitted to this office by aforesaid means on or before the bid submission end date and time, the Technical Bid of those tenderer will be opened, but will be rejected.
    - (i) Earnest Money Deposit (EMD) of Rs. 20,000 (Rs. Ten thousand only) shall be paid through online on E-Chhawani portal.
    - (ii) Non refundable Registration Fee of Rs. 1000/-(Rs. One thousand only) shall be paid through online on E-Chhawani portal.
    - (iii) Non refundable Tender Fee of Rs 2000/- (Rs. Two thousand only) shall be paid through online on E-Chhawani portal.
    - (iii) Tender Conditions Acceptance Certificate (Format as per Appendix A).
    - (iv) Undertaking: Original copy of a notarized undertaking on Non-Judicial Govt. Stamp Paper of Rs. 100/- stating that the firm is not in the past 5 years blacklisted by any Govt./Semi Govt Department or any public sector undertaking for executing any work for which the firm is registered and that the applicant has not been convicted by any competent court of law in or outside India and no trial for any criminal case is pending against him before any competent court of law.

  - (iv) Scanned copy of license / registration with Animal welfare Board of India.
  - (v) Scanned copy of experience certificate / supply orders of last 2 years showing that the firm has minimum two years of successful experience in similar nature of work to any state/central government, Local Bodies, Municipal Corporation, Nagarpalika, Zilla Parishad etc.
  - (vi) Address Proof Electricity bill / Telephone bill etc.
  - (vii) Scanned copy of a notarized undertaking on Non- Judicial Govt. Stamp Paper of Rs. 100/- stating that the firm is not in the past 5 years blacklisted by any Govt./Semi Govt Department or any public sector undertaking for executing any work for which the firm is registered and that the applicant has not been convicted by any competent court of law in or outside India and no trial for any criminal case is pending against him before any competent court of law.

- 4. <u>Rejection of Bid</u> Canvassing by the Bidder in any form, unsolicited letter and post-tender correction may invoke summary rejection of the bid. Conditional tenders will be rejected.
- 5. <u>Validity of Bids</u> The Bids should remain valid for the period of 120 days from the last date of submission of the Bids.
